PROMOTION DESCRIPTION. The **Employee Appreciation Sweepstakes** (the “**Sweepstakes**”) is a purchase entry and mail-in entry Monthly Sweepstakes that begins on 1/1/26 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 12/31/26 at 11:59:59 PM (ET) (the “**Promotion Period**”). Eligible foodservice non-commercial operators (including K-12) may enter the Sweepstakes during the Promotion Period as more fully detailed in rule #3. For purposes of this Sweepstakes, a “Month” is defined as a standard calendar month. Each Monthly Sweepstakes begins on the first day of the respective Month and ends on the last day of each respective Month. Non-winning Monthly entries will automatically rollover into any remaining Monthly drawing(s). The methods of entry and other details of the Sweepstakes are more fully described below. The Sweepstakes will award two (2) Large Prize winners and two (2) Small Prize winners for each Monthly Sweepstakes (twenty-four (24) Large Prize winners in total and twenty-four (24) Small Prize winners in total for the Sweepstakes).

ELIGIBILITY: Open to foodservice non-commercial operators (including K-12) that sell any of the Participating Products (as defined below); are legal residents of the fifty (50) United States and District of Columbia; are eighteen (18) years of age or older at the time of entry; and are in good standing with the Sponsor at the time of entry and awarding of any prize. Employees of WK Kellogg Co (“**Sponsor**”), its parent company, affiliates, subsidiaries, partners, advertising, promotion and other agencies (collectively, “**Promotion Entities**”) and their immediate family members and/or those living in the same household of each are not eligible to participate. 2. Scan or take a photo of the invoice associated with the Qualifying Purchase which includes the Participating Product(s). Each invoice may only be submitted one (1) time for one (1) entry in the Sweepstakes.

Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within five (5) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to two (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed.
